The Company is pleased to announce it has been advised by its Lead Manager to the Offer, Vested Equities Pty Ltd, that they have received commitments for the \$1.3m minimum subscription under the Offer as noted in the Supplementary Prospectus of 19 August 2019. Completion of the Capital Raising is one of the key conditions precedent to the \$2m Debt Facility drawdown and completion of the acquisition of Industry Pathways Pty Ltd. Key terms of the Debt Facility were summarised in the <u>ASX release dated 19 August 2019</u>.

Trading Update

As previously announced, the stand-alone GO2 business completed a restructure in April 2019. The Company is pleased to reiterate that the financial results of our restructure saw the Company achieve an EBITDA neutral position for the month of June 2019, our first EBITDA positive month in July 2019.

Outlook

It is expected the final conditions precedent, including the finalisation of the Loan agreement with Global Capital Pty Ltd, to completion of the acquisition of Industry Pathways Pty Ltd will occur upon the close of the offer, anticipated to be during the week ending September 6th 2019.

Our focus remains on realising our vision of a national, vertically integrated labour hire and training business which generates positive and growing free cash flow for shareholders. Going forward, we will focus our efforts on growing the profitability of the core GO₂ business and the successful integration of IPW into the GO₂ group, using this as a platform to increase the exposure of the Company across Australia.
